This supplement (the "**Supplement**") is the first supplement to the base prospectus dated 19 July 2018 (the "**Base Prospectus**") of the Euro 5,000,000,000 Conditional Pass-Through Covered Bond Programme (the "**Programme**") of NIBC Bank N.V. (the "**Issuer**") and is prepared to update and amend the Base Prospectus and is supplemental to, forms part of and should be read in conjunction with the Base Prospectus, with any documents incorporated by reference therein, which, in relation to any Covered Bonds that are the subject of Final Terms, must be read and construed together with the relevant Final Terms. Terms defined in the Base Prospectus shall have the same meaning in this Supplement, unless specified otherwise.

This document is an amendment and a supplement to the Base Prospectus within the meaning of article 16 of Directive 2003/71/EC including Directive 2010/73/EU (the "**Prospectus Directive**"). This Supplement has been approved by the Dutch Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*, the "**AFM**") in its capacity as competent authority under the Prospectus Directive and Dutch securities laws.

The Base Prospectus and this Supplement are available free of charge on the website of the Issuer at www.nibc.com and are available for viewing at the specified office of the Principal Paying Agent (Citibank, N.A., London Branch) at Citigroup Center, Canada Square, Canary Wharf, London, E14 5LB, United Kingdom and the office of the Issuer at Carnegieplein 4, 2517 KJ, The Hague, the Netherlands, where copies of the Base Prospectus and this Supplement and any documents incorporated by reference may also be obtained free of charge.

Covered Bonds may not be offered, sold or delivered within the United States or to United States persons as defined in Regulation S under the Securities Act, except in certain transactions permitted by US tax regulations and the Securities Act. CERTAIN AMENDMENTS TO THE BASE PROSPECTUS

This Supplement is prepared in connection with:

1. the publication of the Issuer's condensed consolidated interim financial report 2018 (the "**Interim Report 2018**");
2. incorporation of the following press releases issued by the Issuer:
 - (a) "NIBC reports strong net profit H1 2018 of EUR 84 million and increased interim dividend to EUR 0.25 per share" (29 August 2018); and
 - (b) "Susi Zijderveld and Angelien Kemna appointed to Supervisory Board NIBC" (27 August 2018);(together referred to as the "**Press Releases**");

The above qualifies as significant new factors relating to the information included in the Base Prospectus, which is capable of affecting the assessment of any Covered Bonds to be issued.

The Interim Report 2018 and the Press Releases shall be deemed to be incorporated in, and to form part of, this Supplement. This Supplement is supplemental to, forms part of and should be read in conjunction with, the Base Prospectus. Terms defined in this Supplement shall have the same meaning in the Base Prospectus, unless specified otherwise.

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into this Supplement, and (b) any other statement in or incorporated by reference in the Base Prospectus, the statements under (a) above will prevail.

The following amendments are made to the text of the Base Prospectus:

1. In chapter "20. DOCUMENTS INCORPORATED BY REFERENCE", page 209, the following new paragraphs shall be inserted after paragraph (d):
 - "(e) the Issuer's condensed consolidated interim financial report for the six months period ended 30 June 2018, as set out on pages 3 up to and including 78, the auditor's review report related thereto, as set out on page 79, and the Alternative Performance Measures as set out on pages 80 up to and including 88, all as included in the publicly available "Condensed Consolidated Interim Financial report 2018 NIBC Bank N.V.";
 - (f) the press release issued by the Issuer on 29 August 2018 entitled "NIBC reports strong net profit H1 2018 of EUR 84 million and increased interim dividend to EUR 0.25 per share";
 - (g) the press release issued by the Issuer on 27 August 2018 entitled "Susi Zijderveld and Angelien Kemna appointed to Supervisory Board NIBC".
