This fourth supplement (the "**Fourth Supplement**") is the fourth supplement to the offering circular dated 18 June 2014 (the "**Original Offering Circular**") as supplemented by the first supplement dated 23 September 2014 (the "**First Supplement**"), the second supplement dated 11 November 2014 (the "**Second Supplement**") and the third supplement dated 4 March 2015 (the "**Third Supplement**" and together with the Original Offering Circular, the First Supplement and the Second Supplement, the "**Offering Circular**") of the Euro 20,000,000,000 Programme for the Issuance of Debt Instruments (the "**Programme**") of NIBC Bank N.V. (the "**Issuer**") and is prepared to update and amend the Offering Circular and is supplemental to, forms part of and should be read in conjunction with the Offering Circular, with any documents incorporated by reference therein, which, in relation to any Notes that are the subject of Final Terms, must be read and construed together with the relevant Final Terms. Terms defined in the Offering Circular shall have the same meaning in this Fourth Supplement, unless specified otherwise.

This document is an amendment and a supplement to the Offering Circular within the meaning of article 16 of Directive 2003/71/EC including Directive 2010/73/EU (the "**PD Amending Directive**") (the "**Prospectus Directive**"). This Fourth Supplement has been approved by the Dutch Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*, the "**AFM**"), which is the Dutch competent authority for the purpose of the Prospectus Directive and relevant implementing measures in the Netherlands, as a supplemental prospectus issued in compliance with the Prospectus Directive, Commission Regulation EC No. 809/2004 (the "**Prospectus Regulation**") and relevant implementing measures in the Netherlands for the purpose of giving information with regard to the issue of Notes under the Programme.

This Fourth Supplement is prepared in connection with the publication of the condensed consolidated financial report for the year ended 31 December 2014 of the Issuer dated 3 March 2015 (the “**Report**”)

The above qualifies as significant new factor relating to the information included in the Offering Circular set forth on pages 31, 105, 106, 123 and 124, which is capable of affecting the assessment of any Notes to be issued.

The Report shall be deemed to be incorporated in, and to form part of, this Fourth Supplement. This Fourth Supplement is supplemental to, forms part of and should be read in conjunction with, the Offering Circular. Terms defined in this Fourth Supplement shall have the same meaning in the Offering Circular, unless specified otherwise.

To the extent that there is any inconsistency between (a) any statement in this Fourth Supplement or any statement incorporated by reference into the Offering Circular, and (b) any other statement in or incorporated by reference in the Offering Circular, the statements under (a) above will prevail.

The following amendments are made to the text of the Offering Circular.

1. In the chapter “DOCUMENTS INCORPORATED BY REFERENCE.”, page 31, the following wording shall be added:

“The condensed consolidated financial report for the year ended 31 December 2014 of the Issuer dated 3 March 2015.”

2. On page 105, paragraph 4.1 “Financial statements”, the following wording shall be added:

“As set forth under “*Documents incorporated by reference*”, the condensed consolidated financial report for the year ended 31 December 2014 of the Issuer shall be incorporated in, and form part of, this Offering Circular.”

3. On page 106, paragraph 4.5 “Age of Latest Financial Information”, the following wording shall be added:

“The Issuer has issued the condensed consolidated financial report for the year ended 31 December 2014 on 3 March 2015.”

4. In the chapter “GENERAL INFORMATION”, pages 123 and 124, paragraph “Documents Available”, the following wording shall be included:

“; (xix) the condensed consolidated financial report for the year ended 31 December 2014 of the Issuer dated 3 March 2015.”
