2019 NACE Supplement

NIBC steers its business on its own internal sector classification and organization. Therefore industry sectors based on internal NIBC sector organisation are presented in the 2019 NIBC Bank Annual Report (for example in our Key Figures, p13).

Our corporate loan portfolio can be also mapped to the industry sectors of NACE classification. NACE ("Nomenclature statistique des Activités économiques dans la Communauté Européenne") is the industry standard classification system used in the European Union and is the European implementation of the UN ISIC (International Standard Industry Classification of all economic activities) classifications.

Together with our Annual Report, Pillar III, sustainability reports and other supplements, this NACE supplement supports NIBC's commitments as a member institution of the Dutch Banking Association (NVB) towards 2016 Protocol for Transparent Reporting of Lending ("Protocol transparante rapportage over kredietverlening") and NVB recommendations.

In this supplement, our corporate loan portfolio is reported based on the NACE codes at as detailed a level as possible to provide increased transparency to our stakeholders. NIBC uses NACE 2.2 which has as many as four hierarchical levels. NIBC reports at each of these four levels. In certain cases where a fourth level does not exist within Eurostat NACE, NIBC has added additional code details in line with EU guidance in regard to national and/or sectoral standards in order to provide additional transparency for our stakeholders.
